DUTIES:

A central focus of the incumbent involves decisions to invoke and exercise the Commission's authority to designate products and services for procurement from nonprofit agencies in accordance with the JWOD Act and through a public rulemaking procedure. This process requires a high order of original and creative legal endeavor in order to obtain a reasonable balance of conflicting public and private interest. The process and resulting decisions may results in a protest of the Commission's decision, as they may have an impact of small or large businesses, who may vigorously contest the proposed rulemaking by employing extremely capable legal talent.

Works closely with Commission staff involved in additions to the Procurement Lists and pricing commodities and services to assure proper implementation of legal requirements, policies and procedures.

Legislative drafting and review of proposed legislation impacting the Commission's proposed impacting the Commission's program involves issues which can have the effect of substantially broadening or restricting the activities of the Commission through resolution of competing procurement priorities among the various preferred procurement sources or through other extensions or contractions of the Commission's authority.

Legal review, research and responsibilities carried out by the incumbent are typically of vital importance to the operations and program objectives of the Commission's and are typified by the following examples.

Advises on Laws and regulations relevant to the Commission and other Federal agencies, opinions of Comptroller General and other legal authorities. Ensures analysis of all legal issues and applicable precedents, and develops and presents written opinions and oral arguments in support of pertinent facts and points of law. Determines whether further facts are required and if additional legal questions need to be researched.

QUALIFICATIONS REQUIRED:

Application must have at least five (5) years of post J.D. experience as a Federal attorney, which has equipped the applicant with the particular knowledge, skills, and abilities needed to successfully perform the duties of the this position.

Specialized Education:

You must be a graduate from a law school by the American Bar Association and be a member in good standing of a state, territory of the United States, District of Columbia, or Commonwealth of Puerto Rico bar.

You must be a U.S. Citizen to qualify for this position.

- 6. Ability to supervise a small legal staff and oversee agency Freedom of Information Act and Government ethics functions.
