As an Assistant City Attorney, you will defend lawsuits against the City of Seattle and bring affirmative litigation in practice areas including constitutional, charter, regulatory, ethics, and municipal law litigation and local government litigation work. Additionally, you will be involved in litigation involving the Seattle Police Department, typically defending against § 1983 cases alleging violations of constitutional rights. These claims span from relatively minor matters to intensely litigated cases involving severe injuries, death and/or matters of public importance. Government Affairs litigation matters often attract significant attention from elected officials and media representatives.
