Dear Neighbor:

The City of Vancouver has contracted with Halme Excavating, Inc., of Battle Ground, WA, to install 42 new curb ramps for improved pedestrian accessibility, in keeping with current Americans with Disabilities Act (ADA) standards. These accessibility improvements are being done as part of the City's Pavement Management Program in advance of street work that will take place this summer.

The contractor plans to begin construction on Monday, April 8. Construction will take place along the following corridors:

- **East Mill Plain Boulevard**, from Fort Vancouver Way to Grand Boulevard
- **Northeast 162nd/164th Avenue**, from Northeast 18th Street to Southeast Mill Plain Boulevard

Construction is currently expected to begin along East Mill Plain Boulevard. Work hours will typically be from 7 a.m. to 5 p.m., Monday through Friday, but may run as late as 8 p.m. if needed. Please watch for signage, flaggers, equipment, and sidewalk, lane or shoulder closures. Safety in the construction zone is our highest priority.

Completion of these curb ramp improvements is anticipated by July 2019, in advance of pavement work that will follow this summer. Under federal law, streets being paved are required to be upgraded so that existing curb ramps meet current ADA requirements. In areas where ADA-compliant ramps exist, no changes are required.
