Summer 2018 Session

**FOCUS**: This training provides an excellent education for individuals interested in learning the basics of advocacy, community activists, or anyone looking for additional skills necessary to work in the field of disability services, advocacy, community organizing, the legislative process, or civil rights law.

WHEN: June 5, 2018 – August 7, 2018 A 10-week session consists of eight four-hour classes, a site visit to the State Capitol, and a wrap up and graduation day.

**HOW:** There are three ways you can participate: In-person, Online, or Online-hybrid.

- 1. <u>In-person</u>: Attend class with fellow students on the beautiful DU campus on Tuesdays from 10:00 AM to 2:30 PM
- 2. <u>Online</u>: Be as self-directed student, learning at your own pace. You will participate in a weekly video conference on Tuesday nights from 6:30 8:00.
- 3. <u>Online-hybrid learning option</u>: Combines the self-directed learning on an online student with instructor-led webinars held on Wednesdays from 10 AM 12:30 AM

WHERE: In-Person classes are held at the University of Denver Campus.

#### Fee structure

• \$500 per applicant, \$250 for each additional applicant from the same organization

# **CONTINUING EDUCATION UNITS (CEU)\***

The University of Denver and Colorado Cross-Disability Coalition have teamed up to provide all enrolled students with the opportunity to earn 3 CEU for successful completion of the Basic Advocacy Training Class. This cooperation is a ground-breaking program and a national model for other partnership training programs.

#### What is a CEU?

- CEU stands for Continuing Education Unit. A CEU is a unit of credit equal to ten hours of participation in an accredited program designed for professionals with certificates or licenses to practice various professions.
- Examples of people who need CEUs include engineers, lawyers, CPAs, educators, nurses, architects, mental health professionals, and social workers. CEU records are widely used to provide evidence of completion of continuing education requirements mandated by certification bodies, professional societies, or governmental licensing boards.
- To be able to make this offer, CCDC's advocacy training programs have shown they meet the American National Standards Institute (ANSI)/ IACET standards established for accreditation in our field.

This accreditation program is a unique and valuable opportunity for any individual interested in adding to their professional portfolio. Registration with DU, a one-time \$75 fee paid to DU, and successful completion of the course by April 10, 2018, is required to qualify for this program.

#### **LEGALESE**:

- Acceptance and willingness to undergo a criminal background check will be required to volunteer with the CCDC Advocacy Team
- Cancellation before the start of session is subject to a \$25 fee
- Refunds, after the session begins, are calculated on a pro-rated basis
- CCDC is unable to provide reimbursement for mileage, hotel accommodations, long distance charges, food, etc. for anyone attending the training
