Providing expert and compassionate care to patients with disabilities in a supportive and functional environment is essential to Northwestern Medicine's focus on patient care.

Disabilities can be physical or cognitive, or related to vision, hearing, speech, sensory, mental health, self-care, independence or any combination of the above. They can be short-term or long-term. Examples of medical conditions considered a disability include:

- Physical: multiple sclerosis, muscular dystrophy, cerebral palsy
- Cognitive: intellectual disability, learning disability
- Sensory: autism, hard of hearing, vision impairment
- Mental health: bipolar disorder, major depressive disorder, schizophrenia
- Chronic illness: diabetes, cancer, HIV infection
