- 1. <u>**RESOLUTION 20-2</u> CONTRAFLOW LANES ON FORT WEAVER ROAD.** Requesting the Department of Transportation Services to work with the State Department of Transportation to study, analyze, and make recommendations on the potential use of contraflow lanes, including dynamic lane use control signals, on Fort Weaver Road in Ewa to alleviate traffic congestion during peak travel times.</u>
- 2. **RESOLUTION 19-318 SPEED MITIGATION MEASURES AND PEDESTRIAN SAFETY IMPROVEMENTS IN KAPOLEI.** Requesting the City Administration to immediately release funds to provide for speed mitigation measures and pedestrian safety improvements in Kapolei.

<u>PROPOSED CD1 TO RESOLUTION 19-318</u> (Submitted by Councilmember Pine) – The CD1 (OCS2019-1289/11/25/2019 10:08 AM) makes the following amendments:

- A. Amends the first WHEREAS clause to add "Hawaii."
- B. Amends the third WHEREAS clause to add the following phrases:
 - "In addition to a steep grade, Makakilo Drive has long straightaways that encourage high vehicular speeds;"
 - "On November 20, 2019, a 39-year-old was crossing Makakilo Drive, south of Palailai Street, at 7:00 p.m., outside of a marked crosswalk, when she was struck and killed by a hit-and-run vehicle; and"
- C. Amends the fourth WHEREAS clause to read as follows:

"WHEREAS, regarding Fort Barrette Road:

- Fort Barrette Road is adjacent to a number of popular pedestrian destinations, such as Kapolei Regional Park, Kapolei High School, and Hookele Elementary School; and
- Significant development has occurred along and near Fort Barrette Road, including a hotel, a coffee shop, a gas station, and a convenience store near Hookele Elementary School; and
- Many students from Hookele Elementary School and Kapolei High School cross Fort Barrette Road at its intersection with Kapolei Parkway to get to the newly-opened commercial area featuring

Hele Gas Station, Starbucks, 7-11, and Residence Inn, but such crossing is particularly dangerous because Kapolei Parkway has long straightaways that encourage high vehicular speeds and the crossings are marked only by unsignalized, zebra-striped crosswalks, with few warnings for drivers to slow down for pedestrians; and"

D. Adds a new seventh WHEREAS clause to read as follows:

"WHEREAS, the Council finds the pedestrian injuries and deaths on Makakilo Drive and Fort Barrette Road demonstrate the need for more effective speed mitigation measures, including lights or signals at crosswalks and more warnings advising drivers to slow down; and"

- E. Makes miscellaneous technical and nonsubstantive amendments.
- <u>RESOLUTION 19-309</u> DRIVER'S LICENSE RENEWAL PERIOD FOR SENIOR DRIVERS. Urging the Legislature of the State of Hawaii to enact legislation to increase the driver's license renewal period for seniors 72 years of age or older from every two years to every four years, except as otherwise provided by HRS Chapter 286, Part VI.
