This information packet gives the current action steps and logistics for the May 11 Day of Advocacy Info Night on Zoom and the May 26 Day of Action in Sacramento.

The May 26 Day of Action is a statewide disability advocacy day bringing together community members, organizers, and leaders from across California.

[The National Federation of the Blind of California](#) and [the California Council of the Blind](#) are participating with the California Disability Leadership Alliance in the 2nd annual CDLA Day of Action at the Capitol. The event is centered on disability rights, services, access, and community power. Nothing about us, without us.

Participants will gather at the Capitol, connect with the disability community, and communicate with legislators and staff about issues that affect independence, employment, access, services, and community life.

What you need to do

1. Save the date and attend the May 11 Day of Advocacy Info Night on Zoom if you can. This is the best place to learn what is in this packet, ask questions, and hear updates.
2. Register for the May 26 Day of Action. Event registration is separate from transportation.
3. Choose your transportation. Options include the NFBC Bakersfield route, the LightHouse San Francisco bus option, or your own transportation.

4. If you want the NFBC Bakersfield bus route, use the [bus registration form](#) to request a seat. Contact Cheryl Thurston with questions or to confirm final route details and seat availability.
5. If you want the LightHouse San Francisco bus option, sign up through the LightHouse form. The May 20 training requirement applies only to people using the LightHouse San Francisco bus option.
6. Request accommodations through the Day of Action registration process or by contacting cadlalliance@gmail.com by Monday, May 18, 2026, if needed.
7. Stay connected through the NFBC-Info listserv for updates about AB 2190, digital accessibility, transportation, and advocacy next steps.

NFB and CCB are hosting this Day of Advocacy Info Night to help blind, DeafBlind, and low-vision Californians prepare to participate.

This session is for blind, DeafBlind, and low-vision Californians, as well as community members, allies, and supporters who want to understand the Day of Action and prepare for participation.

We will cover the purpose of the May 26 Day of Action, why our organizations are collaborating, and key advocacy priorities, including AB 2190, digital accessibility, restoration of OIB funding, and broader cross-disability access issues.

We will also review practical logistics, including registration, transportation and bus travel, accessibility accommodations, and how to participate remotely if you are unable to travel to Sacramento.

Participants will learn what to expect at the Capitol, how legislative meetings work, and how to share personal stories effectively with legislators and staff.

Whether you plan to attend in person or support the effort remotely, this session is designed to help our community feel informed, prepared, and connected before May 26.

Transportation Option B: LightHouse San Francisco bus option

Use this section only if you want to ride the LightHouse bus from San Francisco.

Blind people in the Bay Area, including NFB of California members, may want to join the free bus option being provided by LightHouse for the Blind and Visually Impaired.

Free transportation from San Francisco is available for the first 45 people who sign up. Participants will travel together to Sacramento and return the same day.

Required advocacy training for LightHouse bus participants only

This requirement applies only to people using the LightHouse San Francisco bus option. It is not a general requirement for everyone attending the Day of Action.

Format: Virtual, one-hour training

Required for: Participants who sign up for the LightHouse San Francisco bus

In order to participate through the LightHouse bus option on Tuesday, May 26, participants using that transportation option are required to attend the virtual one-hour advocacy training on Wednesday, May 20, 2026, at 6:00 PM PDT.

Transportation Option C: Independent transportation

You may also travel independently. You should still register for the Day of Action and review the accessibility and accommodations information.

Advocacy update: protect access

WE NEED YOU: Protect Access. Join Us in Sacramento on May 26

Right now, critical services that support independence, employment, and community for people with disabilities are at risk.

A major shift in funding has moved resources away from community-based programs and into systems that do not reach everyone. At the same time, access within those systems is limited, leaving many people without the services they need.

This is not a distant policy issue. It is already impacting real people across California. Individuals who rely on these services are facing delays, reduced access, and growing uncertainty. Programs that build independence, provide training, and create community are under increasing pressure.

We cannot stay silent.

We are calling for:

- Support for AB 2190 and digital accessibility
- Restoration of Older Individuals Who Are Blind, or OIB, funding
- A better balance between community-based services and system-based funding
- Timely access for individuals with the highest need
- Greater transparency around waitlists and service availability

This is about protecting access, not just for one program or one organization, but for the broader community. Legislators make decisions based on what they hear and who shows up.

Whether you are directly impacted, a family member, a supporter, or someone who believes in access and independence, your presence matters.
