Metro is in the process of updating its 2016-2019 Coordinated Public Transit – Human Services Transportation Plan for LA County. The plan addresses the regional transportation needs of seniors, persons with disabilities, low-income individuals and veterans. The plan will also address federal requirements per the Federal Transit Administration's (FTA) Section 5310 funding process for urbanized and rural areas. The plan update will:

- > Assess transportation services provided for target population groups.
- > Consider and evaluate current and future transportation needs.
- > Develop goals and strategies to address gaps in existing transportation services.
- > Prioritize projects and programs that will improve mobility for target population groups.
