# **Establishment of an Audible Universal Information Access Service for Florida's blind and print-disabled citizens**

#### **INITATIVE**

To establish an Audible Universal Information Access Service for Florida's blind and print-disabled citizens; to authorize the Public Service Commission to contract for the administration and operation of such system and to provide for the use of a portion of the TDD Relay Service monthly maintenance surcharge to be used to fund such a system.

#### **PURPOSE**

To provide a service that would allow blind and print-disabled Floridians to stay up-to-date on global, national and local news stories and events.

#### **BENEFITS**

Being informed and up-to-date on global, national and local news allows blind and print-disabled individuals to compete in the job market and classroom, become informed residents and voters; gain and for the newly blind and printdisabled regain independence and self-respect..

#### **NEED**

Florida has the largest number of blind residents in the nation, a number that increases as more senior citizens, the fastest growing blind demographic, retire and migrate to the Sunshine State. In fact, there are over 39,000 blind and print-disabled residents who are customers of the Florida Braille and Talking Book Library, all of whom are eligible and would greatly benefit from an Audible Universal Information Access Service.

## **REQUESTED ACTION**

NFB-NEWSLINE is the most effective, efficient and accessible Audible Universal Information Access Service available. This service allows blind and print-disabled Floridians to access more than 250 global, national and local newspapers 24 hours a day, 7 days a week via the telephone at no charge. These eligible Florida residents can also use this free service to access TV Channel listings, which include cable, satellite and local listings.

**Funding Threat:** Currently funding for the NFB-NEWSLINE program in Florida is threatened due to the economic crisis and budget cuts. This would leave over 9,000 blind and print-disabled residents who currently use the program without a comparable source to get in-depth global, national and local news coverage that only newspapers can provide.

**Relevance:** Audible Universal Information Access Services have been established and funded with a portion of the TDD Relay Service monthly maintenance surcharge in approximately 15 other states including Alabama, California, Georgia, Illinois, Minnesota, Rhode Island and Texas.

Action: We are asking for legislators who realize just how important this program is to a large portion of Florida's population to cosponsor an amendment to the Florida Telecommunications Access System Act of 1991, 91-111 chapter 427. This amendment would allow for one quarter of a cent of the current surcharge that funds the TDD relay system to be used to fund an Audible Universal Information Access Service, such as NFB-NEWSLINE, thus providing a valuable and much needed service to Floridians in a time filled with program cuts without raising taxes.

# Proposed Amendment of Florida's Telecommunications Access System Act of 1991

To amend Part 1 of 427.704 of Florida's Telecommunications Access System Act of 1991 relating to the telephone system for the physically impaired, so as to provide for the establishment of a state-wide telecommunication system capable of providing audible universal information access services to blind and print-disabled citizens; to authorize the Public Service Commission to contract for the administration and operation of such system; to provide for the use of a one quarter of a cent of the current monthly maintenance surcharge to be used to fund such system
