FRANKFORT, Ky (April 7, 2025): The Kentucky Office of Vocational Rehabilitation (OVR) has updated its drafted proposed changes to the Vocational Rehabilitation (VR) Services Portion of the 2024-2027 Combined State Plan to implement an Order of Selection. An Order of Selection is a tool defined within the Rehabilitation Act for Vocational Rehabilitation (VR) programs to manage the consumer caseload when there is insufficient funding. OVR has scheduled two public hearings and a 10-day comment period to give stakeholders in the VR community and members of the public the opportunity to provide input and comment on the updated proposed policy changes affecting VR Services.

The primary purpose of the hearings is to present updated information regarding the closure of all priority categories. The U.S. Department of Education's Rehabilitation Services Administration (RSA) recently identified duplicative language in the priority category definitions for Priority Category 1 and Priority Category 2 that affects the original proposed state plan amendment. These definitions were approved by RSA in 2018; however, during this recent amendment submission, RSA identified an issue with the definitions. Given the identification of the duplicative language and the guidance received, OVR will be closing all categories. OVR will address the necessary changes to the definitions through the regulatory process, which allows public input. The agency will work expeditiously to address concerns with the definition and open categories as funding allows and updated regulations are approved. The hearings will focus on the reason for these changes and provide clarity on how they will enhance OVR's commitment to serving individuals with disabilities. Stakeholders in the VR community and members of the public are encouraged to attend.

Proposed Amendment to the Vocational Rehabilitation (VR) Services Portion of the 2024 – 2027 Combined State Plan

Section G. Order of Selection

1. Pursuant to Section 101(a)(5) of the Rehabilitation Act, this description must be amended when the VR agency determines, based on the annual estimates described in description (f), that VR services cannot be provided to all eligible individuals with disabilities in the State who apply for and are determined eligible for services.

The VR agency is implementing an order of selection with one or more priority categories closed.

2. For VR agencies that have defined priority categories describe—

A. The justification for the order

After careful review of the agency's current and projected fiscal and personnel resources, a determination has been made to implement an order of selection. The projected available funds are not adequate to provide the full range of VR services to all eligible individuals with a disability. Factors influencing this decision include analysis of short- and long-term budgetary outlook, staffing projections, VR counselor's caseload size and expenditures, the needs of individuals with the most significant disability incidence, and the State Rehabilitation Council (SRC). Based on these factors, the agency has predicted that it will be unable to provide VR services to all eligible individuals with disabilities who apply for services. When an agency determines after assessing available projected funds and resources that it will not be able to provide services to all qualifying individuals, the agency must implement an order of selection to ensure that individuals with the most significant disability are prioritized.

The following factors will not be considered: duration of residency; type of disability; age, sex, race, color, or national origin; source of referral; type of expected employment outcome; the need for specific services except those services provided in accordance with 361.36(a)(3)(v), or anticipated cost of services required by an individual; or income level.

<u>B. The order (priority categories) to be followed in selecting eligible individuals to be</u> <u>provided VR services ensuring that individuals with the most significant disabilities are</u> <u>selected for services before all other individuals with disabilities; and</u>

OVR, in consultation with the State Rehabilitation Council (SRC), has determined that it will not be able to serve all eligible individuals with a disability and must implement an order of selection.

In accordance with 34 CFR 361.36(a)(1), when an agency determines that it will not be able to provide services to all eligible individuals in the state who apply for the services, the agency must implement an order of selection. Based on factors stated in the justification for implementing an order of selection in this section, the agency will prioritize those individuals with the most significant disability by the assurance of being served, first.

The agency has the following four (4) priority categories to be followed in selecting eligible individuals to be provided VR services to ensure those individuals with the most significant disabilities are selected for services before other individuals with disabilities:

Priority Category	Definition	Status
Category 1	Eligible individuals with a most significant disability that limit three (3) or more functional capacities	Will be closed
Category 2	Eligible individuals with a most significant disability that limit two (2) functional capacities.	Will be closed
Category 3	Eligible individuals with a significant disability that limit one (1) functional capacity.	Will be closed
Category 4	Eligible individuals with a non-significant disability.	Will be closed

Definitions

OVR defines priority category terms as follows:

<u>Eligible individual</u> means an individual who has been determined by the office to meet the basic conditions of eligibility for vocational rehabilitation services.

Individual with a most significant disability means an individual who has a disability that limits two (2) or more areas of functional capacity.

Individual with a significant disability means an individual who has a disability that limits one (1) functional capacity.

Non-significant disability means a disability that does not limit a functional capacity.

Functional Capacity means the capacity to perform tasks required in employment including a.) mobility; b.) communication; c.) self-care; d.) self-direction; e.) interpersonal skills; f.) work tolerance; or g.) work skills.
