<u>**DUTIES:**</u> Under the supervision of the Director, Victims of Crime Compensation Office, or other supervisory official within the Department of Law and Public organizes and conducts basic, introductory training courses, classes and workshops for the purpose of providing outreach services and improving employee and/or organizational goals, objectives, and performance; does other related duties.

REQUIREMENTS

EDUCATION: Graduation from an accredited college or university with a Bachelor's degree.

EXPERIENCE: One (1) year of experience organizing and conducting employee training programs such as new-hire orientation, in-service, refresher, or other similar training and development classes/courses; or one (1) year of teaching experience in elementary school through college which shall have included curriculum development and/or the organization of learning programs.

NOTE: Applicants who do not possess the required education may substitute work experience on a year-for-year basis with thirty (30) semester hour credits being equal to one (1) year of experience.

NOTE: Positions will be filled on a part-time, temporary basis. Candidates selected to fill vacancies will be limited to 944 work hours in a fiscal year.

PREFERENCE: Preference will be given to applicants who possess a Master's degree in Social work or with a Bachelor's degree with a major course of study in the social sciences or in criminal justice. A copy of your transcript must be provided to receive any preference.
