<b>DEFINITION</b>	Under direction of a supervisory official in a state department, institution, or agency, assists in establishing and maintaining preventive maintenance and repair records; performs varied mechanical tasks related to the installation, minor maintenance, and repair of vehicles both in the garage and the field; dispatches vehicles in need of extensive repairs to motor pool facilities; is responsible for daily distribution, coordinating, and recordkeeping of all assigned state vehicles; does related work as required.				
<b>REQUIREMENTS</b>					
<b>EDUCATION</b>					
<b>EXPERIENCE</b>	A minimum of two (2) years of work experience which shall include making inspections and minor repairs to motorized vehicles.				
<b>NOTE</b>	Appointees must possess a driver's license valid in New Jersey.				
<b>NOTE FOR FOREIGN DEGREES</b>	Degrees and/or transcripts issued by a college or university outside of the United States must be evaluated by a reputable evaluation service at your expense. The evaluation must be included with your submission. Failure to submit the required evaluation may result in an ineligibility determination.				
<b>LICENSE</b>	Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.				
<b>IMPORTANT NOTICE</b>					
<b>RESIDENCY</b>	Effective 9/1/11, NJ PL 70 (NJ First Act), requires all State employees to reside in New Jersey, unless exempted under the law, or current employees who live out-of-state and do not have a break-in service of more than 7 calendar days, as they are "grandfathered." New employees or current employees who were not grandfathered and who live out-of-state have one year after the date of employment to relocate their residence to New Jersey or request an exemption. Current employees who reside in NJ must retain NJ residency, unless he/she obtains an exemption. Employees who fail to meet the residency requirements or obtain an exemption will be removed from employment.				
<b>NOTE(S)</b>	<ul style="list-style-type: none"> <li>* Applicable regular or special re-employment list(s) established as a result of a layoff will be used before promotions are made.</li> <li>* <b>Telework:</b> This position may be eligible to participate in the Department's pilot "Telework Program", which offers eligible employees the opportunity to work remotely for up to two (2) days per week, as approved by management. Details on this, and other benefits, will be made available throughout the interview process.</li> <li>* <b>Covid Screening:</b> Certain DHS positions may require COVID-19 vaccination or may be subject to testing/screening.</li> <li>* <b>SAME Applicants:</b> If you are applying under the NJ "SAME" program, your supporting documents (Schedule A or B letter), must be submitted along with your resume by the closing date indicated above.
