Stephanie D. Vance, the "Advocacy Guru" of Advocacy Associates, LLC is the author of four books on advocacy, Government by the People: How to Communicate with Congress, the fabjob.com guide; Get a Job on Capitol Hill; Citizens in Action: A Guide

to Influencing Government and the recently released Advocacy Manual: A Practitioner's Guide.

She has over 20 years of experience in Congressional affairs, having worked in a prominent DC law firm, lobbied for National Public Radio and worked in various Congressional offices, holding positions as Legislative Director and Staff Director.
