GENERAL JOB DESCRIPTION

This is an exciting opportunity for an experienced Behavior Specialist to participate in the implementation of a new, innovative, results-oriented life enrichment program for special young adults and their families. The Behavior Specialist is responsible for developing positive behavioral interventions and supports for members of the Tessera Center for Lifelong Learning and providing coaching for Instructional Staff.

Tessera is looking for an experienced Behavior Specialist who believes that every person has the ability to achieve success with appropriate supports. This position requires excellent problem solving and interpersonal skills, in addition to extensive knowledge in positive behavioral interventions and supports including but not limited to: Collaborative Problem Solving, Positive Behavior Intervention Supports, Sensory Integration, and Social Thinking. This position will report to the Program Director.

DUTIES AND RESPONSIBILITIES

- In collaboration with the Program Director and program staff, develop center-wide positive behavioral interventions and supports, as well as individualized behavior support plans.
- Provide staff training, coaching and support in the implementation of individualized behavior support plans.
- As a member of the enrollment team, provide input and recommendations to support enrollment decisions.
- Provide recommendations that support the successful transition of new students into center programs.
- Participate in individual program planning and person centered planning meetings.
- Utilize a variety of resources and strategies that support member engagement/participation in center activities.
- Provide monthly progress updates that inform future planning.
- Maintain current understanding of industry best practices by attending continuing education trainings, as well as participating in professional disability related organizations.
- Perform other duties as assigned.

REQUIREMENTS
