- 4. Work at the Local, State and Federal levels to achieve regulatory compliance and in accordance to various funding requirements.
- 5. Maintain best practice knowledge in Independent Living and services for individuals with disabilities to include transportation, consumer directed care, technology, housing, employment, youth transition and advocacy.
- Maintain effective communication with State Independent Living Council (SILC) and collaborate with the SILC to develop and monitor the State Plan for Independent Living (SPIL).
- 7. Maintain effective communication with Association of Centers for Independent Living in Washington (*ACIL-WA*) and collaborate with ACIL-WA to support the SPIL.

- 9. Ensure compliance required by funding entities and other local, State and Federal regulatory agencies.
