Rich Donovan Report: A Sneak Peak on Return on Disability

Imagine the ability to invest in public companies based on their responsiveness to individuals with disabilities. You will soon likely have that option based on the work of RSC's National Disability Employment Awareness Month (NDEAM) speaker Rich Donovan.

Based on their corporate actions to maximize Return on Disability (RoD), Donovan and business partner Brian Dawson have created the RoD 100, an index of the top 100 companies in the LargeCap space.

"We have found that companies that perform well



in disability are highly responsive to their customers, and thus outperform peers revenue growth," Donovan and Dawson. They add, "Disability is an inspiration for lean process, breakthrough innovation and a new source of talent, driving productivity. Our research shows that companies that score well RoD consistently grow shareholder value measured by long-term stock price appreciation."

The new RoD 100 is based on publicly observable data points on how a

company interacts with individuals with disabilities, labeling this activity RoD. We will be making the full report available in the coming weeks as it is released to the public.
